Details of service required are given below:

1. Offline solution for data entry and MIS to be used internally by Deputy Commissioner Office Jammu / Tehsildar Offices.
2. Subscriber base is more than 50000 which may increase or decrease as per requirement. The subscribers have to be paid rent at least bi-annually.
3. Banks should provide secure transaction gateway within the DC Office / Tehsildar office which will be used by the authorized persons of the Deputy Commissioner for directly transferring the rent amount from designated bank accounts to the subscribers.
4. Bank also has to provide facility to pre-mapping of accounts for protecting unauthorized transactions.
5. Facility for information to the subscriber through email / SMS for informing the subscriber regarding transaction.
6. Facility for re-conciliation of credited amount and other MIS reports.
7. View and E-Mail Facility of statements / reports to the designated officers whenever required.
8. Customized windows / interface as per format prescribed in acquaintance roll.
9. All transactions must have of highest level of multilayer security features.
10. All the facilities / services to be provided free of cost.
